This guide has been designed to assist in resolving the variety of **Validation Errors and Queries** which can occur during the generation of the **Spring 2026 School Census**.

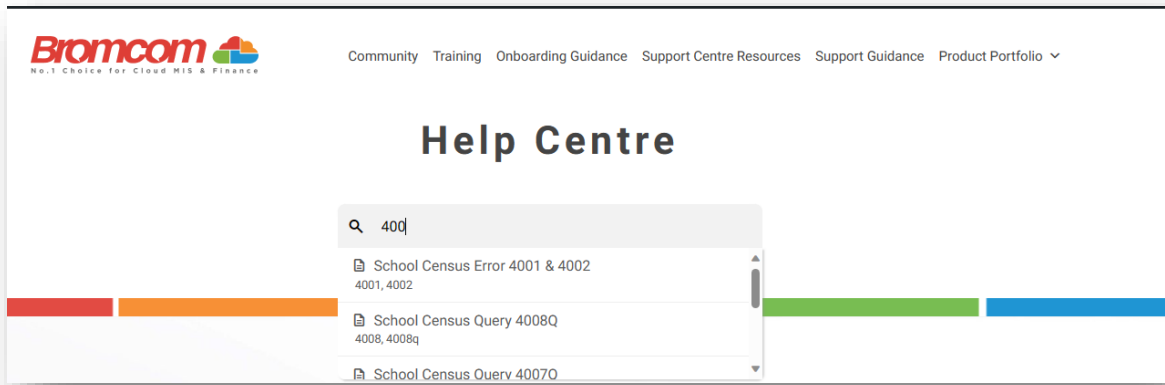

Error	100	Reference date must be present and valid for term.	The <b>Reference Date</b> for your chosen <b>Census</b> is automatically entered; therefore, this error will potentially only show if you have changed this date. The correct value for the <b>Spring 2026 Census</b> is <b>15/01/2026</b>
Error	110	School name missing.	Enter your <b>School Name</b> into the system via the <b>School Details Panel</b> of the following screen: <b>Path:</b> <a href="#">Config &gt; Administration &gt; Core Details</a>

Error	120	Phase is missing or invalid.	Select/Check your <b>School Phase</b> setting via the following screen: <b>Path:</b> <a href="#">Config &gt; Administration &gt; Characteristics</a>

Query	300Q	Please check boarding school with a majority of day pupils	<b>Spring Census - Special Schools Only</b> Ensure that the appropriate School Organisation value is selected on the <b>Census</b> Entry Page and that the students have the correct Student Boarder Status on the Key Data panel on the below page. <b>Path:</b> <a href="#">Students &gt; View Student Details</a>
Error	310	Approved maximum for day pupils is missing	<b>Spring Census - Special Schools Only</b> Ensure that the value for Max Day pupils was entered on the <b>Census Data Entry</b> page
Error	320	Approved maximum for boarding pupils is missing (or, for hospital special schools, is provided when it is not required)	<b>Spring Census - Special Schools Only</b> Ensure that the value for Max Boarders was entered on the <b>Census Data Entry</b> page or left empty if Hospital was selected for Accommodation.

Query	340Q	Please check more boarding pupils on roll than the approved maximum	<b>Spring Census - Special Schools Only</b> Ensure that the Max Boarders value is set correctly on the <b>Census Data Entry</b> page and that all students have accurate Student Boarder Status in the Key Data panel on the below page. <b>Path:</b> <a href="#">Students &gt; View Student Details</a>
Error	350	Boys on roll not provided, or age not in range 2 to 27	<b>Spring Census - Special Schools Only</b> Ensure that the value for Minimum and Maximum Male age is set correctly and that at least one student has been retrieved in the pupil reconciliation section of the <b>Census Data Entry</b> page
Error	360	Girls on roll not provided, or age not in range 2 to 27	<b>Spring Census - Special Schools Only</b> Ensure that the value for Minimum and Maximum Female age is set correctly and that at least one student has been retrieved in the pupil reconciliation section of the <b>Census Data Entry</b> page
Error	370	Approved maximum age (boys) is shown but there is no minimum, or vice versa	<b>Spring Census - Special Schools Only</b> If Maximum Male age has been entered on the <b>Census Data Entry</b> page, then an appropriate Minimum age must also be included.
Error	380	Approved maximum age (girls) is shown but there is no minimum, or vice versa	<b>Spring Census - Special Schools Only</b> If Maximum Female age has been entered on the <b>Census Data Entry</b> page, then an appropriate Minimum age must also be included.
Error	390	Approved maximum age (boys) must be equal to or greater than minimum	<b>Spring Census - Special Schools Only</b> If Maximum Male age has been entered on the <b>Census Data Entry</b> page, then an appropriate Minimum age must also be included.

Error	630	Number of appeals withdrawn plus heard do not equal those lodged for Infant Classes.	<b>Spring Return Only</b> Via the <b>Admission Appeals Panel</b> of the <b>Census Data Entry Page</b> , check that the values you entered Infant Admission Appeals <b>Withdrawn</b> and Infant Admission Appeals <b>Heard</b> , total no more than the value entered Infant Admission Appeals <b>Lodged</b> .
Error	640	Appeals upheld plus appeals rejected should match the number of appeals heard.	<b>Spring Return Only</b> Via the <b>Admission Appeals Panel</b> of the <b>Census Data Entry Page</b> , check that the values you entered Infant Admission Appeals <b>Upheld</b> and Infant Admission Appeals <b>Rejected</b> , total the same as the value entered Infant Admission Appeals <b>Heard</b> .
Error	920	Number of Part-Time pupils not at school is missing.	<b>Spring Return Only</b> Via the <b>Pupil Reconciliation Panel</b> of the <b>Census Data Entry Page</b> , make sure that a value has been entered into <b>Unscheduled part-time</b> . The default entry for this field = '0', therefore unless you remove this value, this error will not show.
Error	930	More part-time pupils not in school than Total Part-time pupils registered.	<b>Spring Return Only</b> Via the <b>Pupil Reconciliation Panel</b> of the <b>Census Data Entry Page</b> , make sure that the value you have entered <b>Unscheduled part-time</b> is no more than the number of Students which you have registered with <b>Attendance Mode</b> = 'Part-Time' which is set via the <b>Key Data Panel</b> of the following screen:
Error	940	Number of Private Study pupils is missing.	<b>Spring Return Only</b> Via the <b>Pupil Reconciliation Panel</b> of the <b>Census Data Entry Page</b> , make sure that a value has been entered into <b>Private study</b> . The default entry for this field = '0', therefore unless you remove this value, this error will not show.
Error	950	Number of pupils at another school is missing.	<b>Spring Return Only</b> Via the <b>Pupil Reconciliation Panel</b> of the <b>Census Data Entry Page</b> , make sure that a value has been entered into <b>Attending other schools</b> . The default entry for this field = '0', therefore unless you remove this value, this error will not show.
Error	953	Number of Pupils on Work Experience is missing.	<b>Spring Return Only</b> Via the <b>Pupil Reconciliation Panel</b> of the <b>Census Data Entry Page</b> , make sure that a value has been entered into <b>Work Experience</b> . The default entry for this field = '0', therefore unless you remove this value, this error will not show.

Error	957	Number of Pupils at FE Colleges is missing.	<b>Spring Return Only</b> Via the <b>Pupil Reconciliation Panel</b> of the <b>Census Data Entry Page</b> , make sure that a value has been entered into <b>FE College study</b> . The default entry for this field = '0', therefore unless you remove this value, this error will not show.
Error	1000	Pupil reconciliation does not match number of Pupils on Roll	<b>Spring Return Only</b> This error should not be possible to be received as Pupil Reconciliation is performed during the Validation of the <b>School Census</b> . If within the <b>Pupil Reconciliation Panel</b> , the fields <b>Total pupils</b> and <b>Number of pupils on roll</b> do not match, you are prompted to make this correction before the Validation can be done. Therefore, if you do encounter the error, please double check you have followed the <b>Census</b> guidelines and confirm the figures in the pupil reconciliation panel.
Query	1010Q	Please check: 10% or more of pupils not in class at selected time	<b>Spring Return Only</b> <b>Primary and Middle Deemed Primary Schools:</b> Via the <b>Pupil Reconciliation Panel</b> of the <b>Census Data Entry Page</b> , make sure that the value of <b>Private study + Attending other schools</b> is less than 10% of the value of ( <b>Number of pupils on roll</b> – ½ ( <b>Unscheduled part-time</b> )).  <b>Spring Return Only</b> <b>Secondary Schools:</b> Via the <b>Pupil Reconciliation Panel</b> of the <b>Census Data Entry Page</b> , make sure that the value of <b>Private study + Attending other schools + Work Experience + FE College Study</b> is less than 10% of the value of <b>Number of pupils on roll</b> .
Error	1050	Class name is missing.	<b>Spring Return Only</b> This error should not be possible to be received as Bromcom MIS forces a <b>Class Name</b> before it is accepted into the system.  To review the Classes which the <b>Census</b> has referenced, please see the <b>Class Information Panel</b> of the <b>Census Data Entry Page</b> .
Error	1060	Two (or more) classes have the same name.	<b>Spring Return Only</b> This error should not be possible to be received as Bromcom MIS forces a unique <b>Class Name</b> before it is accepted into the system.  To review the Classes which the <b>Census</b> has referenced, please see the <b>Class Information Panel</b> of the <b>Census Data Entry Page</b> .
Error	1070Q	Please check: Number of teachers in class is missing or invalid	<b>Spring Return Only</b> Via the <b>Class Information Panel</b> of the <b>Census Data Entry Page</b> , make sure that a value has been entered into the <b>Teachers</b> Column for all Classes displayed. Each Class will automatically show '0' or more Teachers, therefore unless you remove this value, this error will not show.
Error	1090	Number of support staff in class is missing.	<b>Spring Return Only</b> Via the <b>Class Information Panel</b> of the <b>Census Data Entry Page</b> , make sure that a value has been entered into the <b>Support Staff</b> Column for all Classes displayed. Each Class will automatically show '0' or more Support Staff, therefore unless you remove this value, this error will not show.
Error	1100	Class with no staff.	<b>Spring Return Only</b> Via the <b>Class Information Panel</b> of the <b>Census Data Entry Page</b> , make sure that each Class has 1 or more Teachers or Support Staff assigned.

Category	Sequence	Detail (provided by DfE)	Comments/Resolutions
Query	1110Q	Please check: no support staff reported for any class.	<b>Spring Return Only</b> Via the <b>Class Information Panel</b> of the <b>Census Data Entry Page</b> , review the values in the <b>Support Staff</b> Column as it is expected that the Total of all Support Staff for the displayed Classes should exceed '0'.
Error	1130	Class Type is missing or invalid	<b>Spring Return Only</b> Via the <b>Class Information Panel</b> of the <b>Census Data Entry Page</b> , make sure that each Class has <b>Class Type</b> 'O' or <b>Class Type</b> 'N' displayed.
Error	1140	Class year group is missing or invalid for this phase of school.	<b>Spring Return Only</b> Via the <b>Class Information Panel</b> of the <b>Census Data Entry Page</b> , review the values in the <b>Year Group</b> Column.
Query	1150Q	Please check: Class type and class year group different	<b>Spring Return Only</b> Via the <b>Class Information Panel</b> of the <b>Census Data Entry Page</b> , make sure that each Class showing with <b>Class Type</b> = 'N,' has a <b>Year Group</b> = 'N1' or 'N2'.
Query	1155Q	Please check class type and class year group different.	<b>Spring Return Only</b> Via the <b>Class Information Panel</b> of the <b>Census Data Entry Page</b> , make sure that each Class showing with <b>Year Group</b> = 'N1' or 'N2', has a <b>Class Type</b> = 'N'.
Error	1160	Class key stage not present or invalid	<b>Spring Return Only</b> Via the <b>Class Information Panel</b> of the <b>Census Data Entry Page</b> , you will see that the <b>Key Stage</b> value for each displayed Class is automatically assigned from the selected <b>Year Group</b> and is not alterable; therefore, this error should not occur.
Error	1170	Class activity is missing or invalid	<b>Spring Return Only</b> Via the <b>Class Information Panel</b> of the <b>Census Data Entry Page</b> , make sure that you have selected an <b>Activity</b> for each displayed Class.
Query	1180Q	Please check activity shown as Other for all classes.	<b>Spring Return Only</b> Via the <b>Class Information Panel</b> of the <b>Census Data Entry Page</b> , make sure that you have selected the correct <b>Activity</b> for all displayed Classes, as it would be expected that at least 1 Class shows with something other than 'OT'.
Error	1190	Class year group and key stage not consistent	<b>Spring Return Only</b> Via the <b>Class Information Panel</b> of the <b>Census Data Entry Page</b> , you will see that the <b>Key Stage</b> value for each displayed Class is automatically assigned from the selected <b>Year Group</b> and is not alterable; therefore, this error should not occur.
Error	1200	Number of home pupils in class is missing.	<b>Spring Return Only</b> Via the <b>Class Information Panel</b> of the <b>Census Data Entry Page</b> , make sure that each Class displayed has a value for <b>On Roll Students</b> assigned. This field would always have a value by default; therefore, unless you remove this value, this error will not show.
Error	1210	Number of guest pupils in class is missing.	<b>Spring Return Only</b> Via the <b>Class Information Panel</b> of the <b>Census Data Entry Page</b> , make sure that each Class displayed has a value for <b>Guest Students</b> assigned. This field would always have a value by default; therefore, unless you remove this value, this error will not show.
Error	1220	Class with no pupils.	<b>Spring Return Only</b> Via the <b>Class Information Panel</b> of the <b>Census Data Entry Page</b> , make sure that each Class displayed has 1 or more <b>On Roll Students</b> or <b>Guest Students</b> assigned.
